General Terms and Conditions

The Contract comes into force by Enagic's acceptance

Replacement delivery:

In the event of lack of availability, or if the delivery is late or incomplete, no compensation will be payable except in cases of gross negligence. If the product is not available, Enagic may withdraw from the Contract; the Purchaser will be informed of this immediately. Any payments already made will then be reimbursed immediately. However, Enagic is also entitled to send a product which is of equal value in terms of quality and price. The right of revocation also applies for this product.

Due payment and default:

The purchase price is payable on delivery of the contractual acceptance. Without payment Enagic is not enforced to deliver products. The customer will be considered to be in default at the latest 30 days after the payment date without the need for any reminder. From the default date onward, Enagic can demand an administrative charge of epsilon 10.00 for each reminder plus debt collection costs and late-payment interest. The product remains the property of Enagic until payment has been made in full.

Despatch costs:

The costs for shipping are charged to the customer separately.

Subsequent fulfilment:

As regards any possible claim to supplementary performance, Enagic reserves the right to refuse to repair defects if this would be excessively expensive. In this case, the purchaser is entitled only to the supply of an item free of defects.

Data protection:

The data needed to handle the transaction will be recorded in order to process the order, to maintain customer relations and for our own advertising purposes.

The customer may refuse to allow the latter at any time.

Revocation terms

Right of revocation:

You can revoke your contract declaration within two weeks without giving reasons, either in writing (e.g. letter, fax, e-mail) or by returning the item if this was sent to you before the end of the period allowed. The revocation period starts with the receipt of this statement of revocation terms in writing. Sending the revocation or returning the item in good time shall be deemed sufficient to comply with the revocation deadline. Revocation must be sent to Enagic Europe GmbH, 40210 Düsseldorf, Immermannstr.33.

Consequences of revocation:

In the event of an effective revocation, the goods and payments received on both sides must be returned and any benefits derived (e.g. interest) paid back. If you cannot return the goods or services received in whole or in part, or can only return these in a deteriorated state, you must make up the value, if applicable. This may also mean that you must also fulfil the contractual payment obligations for the time up to the revocation. If items were handed over, this does not apply if the deterioration of the item is only caused by your inspection of it, as you would do it in a shop, for example. Otherwise, you can avoid the obligation to reimburse the value for deterioration of the item caused by use for the intended purpose if you do not use the item as if it were your property and do nothing which would adversely affect its value. You must bear the costs of returning the item if the product delivered is what you ordered and if the price of the item to be returned does not exceed a sum of \in 40.00 or, if the price of the item is higher, you have at the time of the revocation not yet made the payment or a contractually agreed part-payment. Otherwise, returning the item is free of charge for you. Obligations to reimburse payments must be met within 30 days. The deadline starts for you with the dispatch of the revocation declaration or the item, and for us with their receipt.
